The Double Irish is a base erosion and profit shifting ("BEPS") corporate tax tool, used mostly by U.S. multinationals since the late 1980s, to avoid corporate taxation on most non-U.S. profits. It is the largest tax avoidance tool in history and by 2010, was shielding USD 100 billion annually in U.S. multinational foreign profits from taxation, and was the main tool by which U.S ...
